

BACK TO BATUU SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. SPONSOR:** Disney Destinations, LLC (“**Sponsor**”), P.O Box 10000, Lake Buena Vista, FL 32830.
- 2. ADMINISTRATOR:** Prize Logic, LLC (“**Administrator**”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033, U.S.A., is the independent agency administering this Sweepstakes.
- 3. ELIGIBILITY:** The Back To Batuu Sweepstakes (“**Sweepstakes**”) is open to legal residents of the fifty (50) United States and the District of Columbia (“**Territory**”), who are at least eighteen (18) years of age as of date of entry. Officers, directors, and employees, and members of their household (defined as people who share the same residence at least three (3) months a year, whether related or not) or immediate family (*i.e.*, parents, children, spouse, siblings, grandparents, step-parents, step-children, and step-siblings of each) and persons residing in such immediate family members' household, of Sponsor, Administrator, Southwest Airlines Co., and each of their respective parent, related, affiliated and subsidiary companies, all other entities involved in the creation, administration, or fulfillment of the Sweepstakes and their respective successors and assigns are not eligible to enter or win. Due to the way Instagram operates its services, Entries (as defined below) from users with protected or private accounts (*i.e.*, Entrant has set their account so that only people the entrant has approved can view their updates) may not be received.

Entrants may create a Facebook account at no cost by visiting <https://www.facebook.com/> or by downloading the Facebook app on a compatible mobile device. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Instagram, Twitter, or Facebook. Each Entrant specifically agrees to release Instagram, Twitter and Facebook from any and all liability associated with this Sweepstakes. Entries will be deemed made

by the authorized account holder of the account the entry is submitted from at the time of entry. The “authorized account holder” is the person who is assigned to the Instagram/Twitter/Facebook account by the online service provider.

4. **HOW TO ENTER:** The Sweepstakes begins at 6:00:00 AM Eastern Time (“ET”) on August 29, 2019 and ends at 11:59:59 PM ET on September 30, 2019 (“**Sweepstakes Period**”). The Administrator’s computer is the official Sweepstakes clock. There are two (2) ways to enter the Sweepstakes – (1) via social media on Twitter, Instagram and/or Facebook; and/or (2) via a postcard entry, all as set forth below:

- A. **Social Media Entry via Twitter, Instagram and/or Facebook** (each, a “**Platform**”): To enter via Twitter or Instagram, during the Sweepstakes Period, an eligible Entrant must log onto their Instagram or Twitter account and become a follower of @WaltDisneyWorld on Instagram or Twitter. The Entrant must then compose a new Instagram post or Tweet that contains (i) a photograph of their experience at *Star Wars: Galaxy’s Edge* at *Walt Disney World*[®] Resort during the Sweepstakes Period; (ii) all of the following hashtags: “#GalaxysEdge” “#BackToBatu” and “#Sweepstakes” (collectively, “**Required Sweepstakes Hashtags**”); and (iii) @WaltDisneyWorld tagged in the post (each, an “**Entry**” and collectively, “**Entries**”).

To enter via Facebook, an entrant may visit the Sponsor’s Facebook Page <https://www.facebook.com/WaltDisneyWorld/> (“**Page**”). During the Sweepstakes Period, Sponsor will post one or more Facebook posts on the Page inviting participants to enter this Sweepstakes (each, an “**Invitation Post**”). To enter the Sweepstakes on Facebook, an entrant must post an Entry (i.e., a photograph showing their experience at *Star Wars: Galaxy’s Edge* at *Walt Disney World*[®] Resort and all of the Required Sweepstakes Hashtags) as a comment to the Invitation Post during the Sweepstakes Period. After posting an Entry, an Entrant will receive one (1) entry into the Sweepstakes.

The content included in the Entry will not be judged or used in any way to determine the winner. By entering the Sweepstakes and using the hashtags “#GalaxysEdge” “#BackToBatu” and “#Sweepstakes”, Entrant hereby agrees to be bound by these Rules. Entries will be deemed made by the authorized account holder of the Instagram account, Twitter account, or Facebook account the Entry is submitted from at the time of Entry. The “authorized account holder” is the person who is assigned to the Instagram account, Twitter account, or Facebook account by the online service provider. An Entrant must have a non-private Twitter account or Instagram account to enter the Sweepstakes using Twitter or Instagram and must be a follower of @WaltDisneyWorld on the platform used for forty (40) days after the end of the Sweepstakes Period for winner notification purposes to be eligible to win/claim a prize. The photograph must be a new Instagram, Twitter, or Facebook post. Placing the Required Sweepstakes Hashtags and tagging @WaltDisneyWorld on an existing photograph posted prior to the start of the Sweepstakes will not be considered a valid Entry.

There is a limit of one (1) Entry per social media Platform during the Sweepstakes Period. Each Entrant may submit a maximum of one (1) Entry per social Media Platform. If an Entrant enters more than one (1) time per Platform, only the first Entry received may, at Sponsor’s sole discretion, be considered valid. An Entrant may use only one (1) Instagram account, one (1) Twitter account, and one (1) Facebook account to enter. Entrants attempting to use multiple Instagram, Twitter, or Facebook accounts or multiple identities may be disqualified at Sponsor’s sole discretion.

B. Mail-In Entry: To enter without posting on a social media Platform, an eligible Entrant may hand-write their complete name (no initials), valid e-mail address and telephone number on a 3½"x5" card ("**Mail-In Entry**") and mail it with sufficient postage to: Back To Batuu Sweepstakes, P.O. Box 251328, West Bloomfield, MI 48325. All Mail-In Entries must be postmarked no later than September 30, 2019, and received on or before October 10, 2019, in order to be eligible.

Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, Mail-In Entries sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address may be deemed incomplete and not valid entries. An Entrant may mail-in one (1) time to receive three (3) Entries into the Sweepstakes.

Regardless of method of entry, there is a limit of three (3) total Entries per person during the Sweepstakes Period. You may receive up to three (3) total Entries in this Sweepstakes using either method of entry (i.e, entry via a social media Platform or a Mail-In Entry) or a combination thereof.

By using the Required Sweepstakes Hashtags with an eligible Entry, Entrant hereby agrees to these Rules, agrees to Sponsor's Privacy Policy (<https://disneyprivacycenter.com>) and Terms of Use (<https://disneytermsofuse.com/>), and acknowledges that their Entry, first name and last initial, and account name may be used by Sponsor and its affiliates in all media (including but not limited to Instagram, Twitter, Facebook and any other Sponsor-related website or social media account) in perpetuity. All Entries are subject to confirmation and/or verification and compliance with these Rules as determined by Sponsor and/or Administrator.

5. ENTRY GUIDELINES AND REQUIREMENTS: Each Entry:

- A.** Must comply with Instagram's, Twitters', and/or Facebook's posting requirements depending upon the platform on which the Entry is posted (as applicable);
- B.** Must include the hashtags "#GalaxysEdge" "#BackToBatuu" and "#Sweepstakes" and tag @WaltDisneyWorld (tagging @WaltDisneyWorld in your post is not required for entries via Facebook);
- C.** Must be the original work of the Entrant (not copied, adapted, or reproduced from any other source and not a collaboration with any other person) and must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity or intellectual property rights, including copyright infringement, or legal or moral rights of any third party, living or deceased (e.g., music, names, logos, symbols, slogans, submissions that belong to others, Entries of other people, quotes from other people, or parodies of other people);
- D.** Must not have been submitted previously in a promotion of any kind;
- E.** Must have approval from any persons appearing in the Entry and the Entrant must be able to provide express written consent of every such person appearing in the Entry to Sponsor and/or

Administrator if requested. If any such person is a minor the Entrant must be their parent/legal guardian;

- F. Must not disparage Sponsor, Sponsor's affiliated companies, Administrator, or any other person or party affiliated with the promotion and administration of this Sweepstakes;
- G. Must not include personally identifiable information in the Entry;
- H. Sponsor discourages use of any logos, brand names or trademarks. Sponsor reserves the right to disqualify the Entry, if Sponsor believes, in its sole and absolute discretion, that there is any inappropriate use of a logo, brand name, or trademark;
- I. Must comply with all other Entry Guidelines and Requirements described in this Section 5 and all other provisions of these Rules;
- J. Must not contain, facilitate, reference, or use material that is dangerous, fraudulent, inappropriate, indecent, lewd, pornographic, obscene, hateful, tortious, defamatory, slanderous or libelous;
- K. Must not contain, facilitate, reference or use material that contains prohibited content which shall include, but is not limited to content that promotes, suggests, or encourages:
 - i. any cruelty to, or mistreatment in any way of animals;
 - ii. gambling, including without limitation, any content related to online casinos, sports books, bingo or poker;
 - iii. the use of firearms/weapons/ammunition, any illegal drugs, prostitution, pornography, nudity, profanity or other adult content, violence, or the use of alcohol or tobacco products;
 - iv. the taking up of arms against any person, government or entity or otherwise challenge or seek to overthrow any government;
- L. Must not contain any viruses, spyware, malware, or other malicious components that are designed to harm the functionality of a computer in any way;
- M. Must not contain, facilitate, reference, or use material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, ethnicity, religion, nationality, disability, sexual orientation, political orientation, citizenship, ancestry, marital status, or age; and
- N. Must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where Entry is created or otherwise promotes any unlawful, illegal, unsafe, dangerous or reckless behavior.

NOTE: If any Entry fails to comply with any of these Entry Guidelines and Requirements or any other provisions of these Rules, Sponsor reserves the right, in its sole discretion, to disqualify the Entrant.

- 6. GRANT OF RIGHTS BY ENTRANT:** Each Entrant hereby grants to Sponsor a non-exclusive, sublicensable, irrevocable and royalty-free worldwide license under all copyrights, trademarks, patents, trade secrets, privacy and publicity rights and other intellectual property rights to use, reproduce, transmit, print, publish, publicly display, exhibit, distribute, redistribute, copy, index, comment on, modify, adapt, translate, create derivative works based upon, publicly perform, make available and otherwise exploit such Entrant's Entry(ies), in whole or in part, in all media formats and channels now known or hereafter devised (including, without limitation, on third-party sites and platforms such as Facebook, YouTube, Instagram and Twitter), in any number of copies and without limit as to time, manner and frequency of use, without further notice to Entrant, with or without attribution, and without the requirement of permission from or payment to Entrant or any other person or entity. Entries may be displayed on Sponsor's Instagram, Twitter, and Facebook social media accounts and that any such display by Sponsor or Administrator will have no effect on winner selection, and is for entertainment purposes only.

Additionally, each Entrant consents to the use of the names, account names, social handle names, statements, photographs, videos, voice recordings and likenesses of themselves and any other

person appearing in the Entry(ies) for publicity purposes, as well as any other purpose associated with the Sweepstakes.

If requested, Entrant will sign any documentation that may be required for Sponsor or its designees to make use of the non-exclusive rights Entrant is granting herein in connection with their Entry(ies). Once an Entry is entered into the Sweepstakes, any such posting will be deemed made at the direction of the Entrant within the meaning of the Digital Millennium Copyright Act and the Communications Decency Act.

- 7. WINNER SELECTION, NOTIFICATION, AND VERIFICATION:** The odds of winning a Sweepstakes prize depend on the number of eligible Entries received during the Sweepstakes Period. Sponsor's decisions regarding the administration and operation of the Sweepstakes and the selection of the potential winner are final and binding in all matters related to the Sweepstakes. On or around October 11, 2019, Administrator will randomly select seventy-seven (77) potential winners from among all eligible Entries received during the Sweepstakes Period combined (each a "Winner").

Each potential Winner will be notified on either Facebook by a direct message, on Twitter or Instagram by a Direct Message from @WaltDisneyWorld, or by e-mail at the e-mail address included in the Mail-In Entry with instructions on how to claim their prize. Each potential Winner who entered via a social media platform must respond to the e-mail address provided in the initial direct message within seventy-two (72) hours with their e-mail address or their prize may (in Sponsor's sole discretion) be forfeited. Each potential Winner will then be notified at the provided e-mail address by the Administrator. Each potential Winner must respond to the initial e-mail notification from Administrator within seventy-two (72) hours of such notification or the prize may (in Sponsor's sole discretion) be forfeited.

Acceptance of a prize shall constitute and signify the Winner's agreement and consent that Sponsor and its designees may use the Winner's name, city, state, likeness, photograph, video and/or prize information in connection with the Sweepstakes for promotional, advertising or other purposes, worldwide, in any and all media now known or hereafter devised, including without limitation, the Internet and without further payment, notification, permission or other consideration, except where prohibited by law.

The potential Winners will be required to execute an Affidavit of Eligibility, a Liability Release, and (where imposing such condition is legal) a Publicity Release (collectively, "**Prize Claim Documents**") within ten (10) calendar days from the date such Prize Claim Documents are sent to the potential Winner. Each Winner's guest will also be required to sign and return a liability and/or publicity release(s) and other paperwork at the same time the potential Winner returns their Affidavit of Eligibility, Liability Release, Publicity Release and other paperwork.

At the sole discretion of Sponsor, disqualification, forfeiture and the selection of an alternate Winner may result from any of the following: (a) a potential Winner's failure to respond to Sponsor's instructions per the initial direct message notification within seventy-two (72) hours (if the potential Winner entered via social media); (b) a potential Winner's failure to respond to Administrator's initial e-mail notification within seventy-two (72) hours; (c) the return of a notification as undeliverable; (d) a potential Winner's failure to provide Administrator/Sponsor with satisfactory proof of age, identity and residency; (e) any non-compliance with these Rules; and (f) failure to execute and return the required Prize Claim Documents within ten (10) calendar days from the date such documents are sent to a potential Winner.

In the event that a potential Winner is disqualified or forfeits their prize for any reason, Sponsor may, at its sole discretion, award the respective prize to an alternate Winner by random drawing from among all remaining eligible entries. In such cases where a prize is not accepted or where a prize is forfeited, there may, as necessary, be up to three (3) alternate drawings, after which the respective prize, if not accepted by an eligible Winner, will not be awarded. Each prize must be claimed by an eligible Winner by November 4, 2019, after which the prize, if not accepted by an eligible Winner, will not be awarded.

8. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

A. Prizes (77): Each Winner will receive a four (4) day/three (3) night vacation to the *Walt Disney World*® Resort near Orlando, Florida (the “**Trip**”) for Winner and one (1) guest (each a “**Prize**”). Prize consists of a four (4) day/three (3) night trip for Winner and one (1) guest (together with the Winner, “**Group**”), including: **[1]** two (2) roundtrip coach/economy class airfares for the Group between the major commercial airport closest to the Winner’s residence (as determined by Sponsor in its sole discretion) and the Orlando International Airport (provided, however, if Winner resides within 250 miles of the *Walt Disney World*® Resort, air fare will not be provided); **[2]** three (3) nights of hotel accommodations during the vacation (one [1] standard room/double occupancy) at a Disney Resort located at the *Walt Disney World*® Resort selected by Sponsor in its sole discretion; **[3]** two (2) round trip ground transfers between the Orlando International Airport and the *Walt Disney World*® Resort via Disney’s Magical Express Service; **[4]** two (2) 4-Day Tickets with Park Hopper® Option; **[5]** access to a special event at *Star Wars: Galaxy’s Edge* on December 4, 2019 and **[6]** a \$200 Disney Gift Card (for Winner only) (subject to restrictions); The ARV of each Prize is \$3,769.16. ARV may vary from actual value, depending on date and point of departure. Any difference between stated and actual value will not be awarded.

Travel must occur between December 3, 2019 and December 6, 2019. No more than seventy-seven (77) Prizes will be available in the Sweepstakes.

B. Prize Conditions: In no event will more than seventy-seven (77) Prizes be awarded. Limit: One (1) Prize per household.

INTERNET/LIMITATIONS OF LIABILITY:** Sponsor, Administrator, Instagram, Inc., Twitter, Inc., Facebook, Inc., Southwest Airlines Co, and each of their respective parent, related, affiliated and subsidiary companies, their advertising, promotion and web design agencies, all other entities involved in the creation, administration, or fulfillment of the Sweepstakes and each of their respective successors, assigns, directors, officers, employees, agents and independent contractors (individually and collectively, “**Releasees**”), are not responsible for technical malfunctions of any kind, including but not limited to interrupted or unavailable network server or other connections; miscommunications; failed, partial, or garbled telephone or computer transmissions; jumbled, scrambled or misdirected Entries or transmissions; insufficient space in Entrant’s e-mail account to receive e-mail; phone, electrical, network, computer hardware or software or program malfunctions, failures or difficulties; other errors, omissions, interruptions, or deletions of any kind, whether due to electronic, human, mechanical, printing, production or technical errors or other causes; or for any damage to any person’s computer or wireless device related to participating in the Sweepstakes.
